To consolidate and grow our position as the region's trusted exchange and clearing house of choice.



A highly regulated derivatives trading and clearing platform, which has global credibility and a proven settlement track record. More than 140 million contracts traded and cleared since inception.



#### **DGCX Market Data**

DGCX Market data contains the information that includes quotation, price, volume, and other market data in respect of major derivatives instruments such as Currencies, Equities, Metals and Hydrocarbons traded on DGCX.

The market data helps to address the financial decision and trading functions, such as, Valuation, Research Analysis, Compliance and Risk-Management requirements.

The DGCX market data classifies into:

- Level 1, displays single best Bid-offer-volume quotes in real-time
- Level 2, displays the five best Bid-offer-volume quotes in real-time
- Full Depth, which displays all limit real-time orders data

DGCX also provides raw data that can be derived into various datasets, gaining deeper insight into market analysis and trading decisions.

DGCX offers simple and upfront licensing solutions such as, licensing for organisations- Display and non-Display, Distribution License- Data Vendor, and Customised license- Raw and Historic data.

DGCX provides a Market Data Platform (MDP) to optimize operations and onboard quickly via multiple flexible API technology formats and approved Data-Vendor connectivity.
